# U.S. Subsidiary Tokyo Tatemono US Ltd. Begins Operations Aimed at Accelerating Business Expansion in the United States

## Promoting Eight Projects Focused on the Multi-family Development

Tokyo Tatemono Co., Ltd. (headquarters: Chuo-ku,Tokyo; Representative Director, President and Chief Executive Officer: Katsuhito Ozawa; hereinafter, "Tokyo Tatemono") hereby announces that Tokyo Tatemono US Ltd., its U.S. subsidiary in Los Angeles, United States, has begun operations. Tokyo Tatemono has participated in Multi-family development businesses in several cities across the United States, starting with the Herndon PJ in 2023. It is currently promoting eight projects. This includes increasingly diverse asset types such as the SilverSpring PJ, Toyko Tatemono's first logistics facility development project in the United States, since May 2025.

# TOKYO TATEMONO US

The United States real estate market is the largest in the world and is also highly transparent. Among advanced countries, the United States is also forecast to enjoy a relatively high population growth rate and economic growth rate in the medium to long term. In addition to high demand for housing, demand for logistics is also expected to grow due to factors such as the expanding e-commerce market. Tokyo Tatemono has positioned business expansion in advanced countries, including the United States, as a medium- to long-term driver of profit growth under its Medium-Term Business Plan (FY2025–FY2027), and will engage in expanding its business scale, aiming to capture investment projects of 20 billion yen or more per year in the United States going forward.


